All applicants approved for credit will be governed by the following:

1. Our terms are net 30 days with no discounts.
2. A service charge of 1 ½ % per month will be charged on all past due accounts. This corresponds to an annual percentage rate (APR) of 18%.
- 3a. No shipment will be made to any account, on an open basis, that will cause that account to exceed the established credit limit, or if the account is beyond 60 days.
- 3b. If an account is beyond 60 days, the account is placed on a COD basis, and will be required to pay for the current purchase plus 20% of the unpaid balance, to obtain any material, until the account is brought up to date.
4. The amount of credit extended to a customer is subject to change or limitation at any time.
5. That in the event of non-payment, the person(s), firm, or corporations to whom the account was extended agrees to pay all expenses of legal proceedings plus reasonable attorney fees.
6. That all statements, including the financial statement, are correct and were provided to Web-Don, Inc. to induce an open line of credit to be established.
7. Advance notice will be given to Web-Don, Inc. of any change in the business structure, ownership, etc. That without such a notice the original owners to whom credit was given will remain responsible and liable. Notice to be given by certified mail with a return receipt requested.
8. A \$25 handling charge will be applied to all returned checks. On all NSF checks not made good within the calendar year, a Form 1099 will be sent along with a copy to the IRS.
9. Credit policies are subject to change at the discretion of the credit department. The applicant agrees to abide by the credit policies of Web-Don, Inc.
10. Permission is granted to Web-Don, Inc. or its agents to contact all references or any source for the purpose of obtaining credit information. Banks, creditors, or lending institutions have my permission to release any and all information requested.

Guaranty Agreement

This GUARANTY AGREEMENT ("Guaranty") is executed and delivered as of the _____ day of _____ 20____, by _____, jointly and severally (hereinafter referred to collectively and individually as the "Guarantor"), for and in consideration of credit being extended by Web-Don, Inc. ("Web-Don") at my request to _____ (hereinafter referred to as the "Company") of which Guarantor hereby unconditionally guarantees to Web-Don the payment of any obligation of the Company to Web-Don. This Guaranty is a guaranty of payment and is not just a guaranty of collection, and Guarantor hereby waives any rights provided under North Carolina General Statutes Section 26-7 and /or any other laws requiring Web-Don to attempt to recover against the Company and/or to realize upon any security or collateral which Web-Don holds for the obligations described herein. It is understood that this guaranty shall be a continuing and irrevocable guaranty and indemnity for any current or future indebtedness of the Company. Guarantor hereby waives notice of default, non-payment and notice thereof and consent to any modification, extension, acceleration or renewal of the obligations of the Company hereby guaranteed. This Guaranty shall be governed by, interpreted and construed in accordance with the laws of the State of North Carolina, without regard to conflict of laws, principles, nor domicile of the parties.

Upon default under this Guaranty, Web-Don may employ an attorney to enforce its rights and remedies and Guarantor hereby agrees to pay Web-Don's reasonable attorneys' fees, plus all other reasonable expenses incurred by Web-Don in exercising any of its rights and remedies upon default. The failure to exercise any such right or remedy under this Guaranty shall not be a waiver or release of such rights or remedies or the right to exercise any of them at any other time.
